- i. Certificate of Incorporation/Registration with Corporate Affairs Commission (CAC) (mandatory);
- ii. Evidence of Company Income Tax Clearance Certificate for the last three (3) years 2018,2019 and 2020 (mandatory) valid till 31<sup>st</sup>December, 2021;
- iii. Evidence of current Pension Compliance Certificate valid till 31<sup>st</sup> December, 2021 (Mandatory)
- iv. Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31<sup>st</sup> December, 2021 (Mandatory)
- v. Evidence of Current Nigerian Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31<sup>st</sup> December, 2021
- vi. Evidence of Registration on National Data Base of Federal Contractors, Consultant and Service Providers by submission of interim Registration Report (IRR) mandatory expiring on 31<sup>st</sup> December, 2021 or valid certificate issued by BPP.
- vii. A sworn Affidavit that none of the Directors has been convicted in any court of Law for any criminal offence.
- viii. Company's Audited Accounts for the last three (3) years 2018,2019 and 2020 showing annual turnover;
- ix. Evidence of Financial Capability to execute the project including reference letter from reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.
- x. Verifiable documentary evidence of similar jobs executed in the last five years including letter of award, valuation certificate, job completion certificate e.t.c
- xi. Firm's profile and Technical qualification of key personnel with photocopies of their academic/professional qualifications.
